Through the Pandemic Recovery Office, the State has made federal funds available through the Municipal Community Learning Center Program. This program authorizes recipients to use funds for critical capital projects that directly enable work, education, and health monitoring. In September 2023, it was determined that the only eligible recipients for these capital funds in Glocester are the libraries. The Town is acting as the grant recipient and passing those grant funds through to the Glocester Manton and Harmony Libraries for capital improvements to their buildings.

The Town of Foster has determined that they are not able to utilize their funding and has offered to pass it to the Town of Glocester for use on the library projects in exchange for allowing Foster residents to use the facilities and participate in any programming at the libraries. This is a similar relationship to other neighboring Towns including Middletown and Newport and Hopkinton and Richmond. In order to formalize this relationship, the Town must submit the attached revised Memorandum of Agreement with the Town of Foster and the attached Memorandum of Agreement with the Glocester Manton and Harmony Libraries.

I am requesting authorization for the Town Council President to sign both attached MOAs. Thank you.

## RE: Request to Sign Agreement for Professional Services

The Town received a Watershed Implementation Grant from the Southeast New England Program for \$250,000, a Rhode Island Decentralized Wastewater Improvement Grant from the US Environmental Protection Agency for \$465,000, and the Town has set aside \$200,000 in American Recovery Program Act (ARPA) funds to fund Decentralized Wastewater Improvements in Chepachet Village.

Focusing on priority properties (cesspools, holding tanks, OWTS in public well radius, within 200' of the river) this project will explore opportunities for innovative and alternative septic systems, educating property owners of different possibilities available and where individual systems are not feasible, look for opportunities to join with neighboring property owners with comparable wastewater needs.

The ultimate goals of the project include:

- 1. Provide financial incentives that lead to the construction of as many wastewater upgrades as financially feasible in Chepachet Village.
- 2. Establish an innovative, third party management entity to ensure the long term viability of these wastewater investments.
- 3. As the results of these upgrades are implemented, reduce the number of properties using point of entry systems on drinking water wells.
- 4. As a result of these upgrades, restore the quality of the Chepachet River and remove the TMDL.

This grant requires no cash contribution from the Town outside of the already allocated ARPA funds. An RFQ was released in November 2023. After a review of responses, Pare Corporation was selected as a qualified consultant for this project. Staff proceeded to work with Pare to refine the scope of work and budget. The agreement was approved by the Board of Contracts on April 29, 2024. I am requesting authorization to sign the attached agreement for professional services with Pare Corporation.

Councilor J. Burlingame stated that this money for paving would leave no money for any other roads.

G.Treml, DPW Director, stated that the state money with the match will be used on only the designated roads so there will be nothing to use on any other roads. G.Treml stated there would be no money for any materials. Councilor J. Burlingame stated his opinion to fund money for paving. Councilor S. Arnold asked K.Scott if the state money with matching funds from the town could be reduced which would free up money to be used for paving on other projects. K.Scott stated that the grant application required specific projects with a budget so the projects would have to be looked at to determine if any could be revised. K.Scott stated that this grant included a very high match. K.Scott stated that the Town does not have to take any of the money. K.Scott stated that the projects submitted to be done as part of the grant are for FY 24 and there is no money in the budget for FY25. Councilor S. Arnold stated that these proposed projects are ones that the town would do anyway. Councilor S. Arnold stated that it is his opinion that this matter be discussed on Monday

Councilor C. Greathouse stated that the Historical Cemeteries have \$12,750 in unused ARPA funds which she suggested be used in place of their budget request of \$6200. Councilor J.Burlingame asked E.Beltram if the amount was correct. E. Beltram stated the amount was correct. Councilor J. Burlingame stated his recommendation to discuss this matter on Monday.

XI. Town Council Correspondence/ Discussion

D.Igliozzi stated that a public hearing would be required as to the purchase of town property. D. Igliozzi stated that there would have to be a finding by Council that the town property is no longer of use to the town. D.Igliozzi stated that both requests are vague and suggested they be on the next agenda.

## XII. Department Head Reports/Discussion

Councilor S. Arnold asked if any department heads had anything to report or if any Councilors had any questions for department heads.

- 1. G.Mosca, EMA Director, stated that the FEMA representatives have met with 1764 residents, businesses and places of worship regarding the storms in December 2023 and January 2024. G.Mosca stated that FEMA has awarded approximately \$142,320.00 of assistance for residents. G.Mosca stated that the application period for assistance regarding these two storms will end on May 20, 2024.
- 2. K.Scott, Town Planner, stated that Glocester did not receive an award from DEM Recreation Grants. K.Scott stated that the total awards for the grants have been 5 million dollars but the amount this time the total to be awarded was reduced to 2 million dollars. K.Scott stated that the awarding system is skewed towards urban communities especially when the amount is lower. K.Scott stated that the point system used is one more favorable to urban communities and that rural communities can't earn certain points because of their rural nature. K.Scott stated a suggestion that she would like to propose a resolution to increase the amount of the grant for the future and try to get other communities to do the same.
