The Rhode Island Office of Energy Resources has made federal Energy Efficiency Conservation Block Grant Program funds available to municipalities. This funding can be used towards energy efficiency upgrades for existing buildings and facilities. The original Agreement was to spend \$22,962.18 funds to make improvements to building weatherization and upgrades to the HVAC equipment at the Police Station. Since the Police Station is not undergoing the extensive renovation that was anticipated, the scope has been changed to replace eight (8) lights at Glocester Memorial Park with LED lights, which will save the Town significantly in electrical costs. This funding does not require a municipal match. I am requesting authorization for the Town Council President to sign the attached Memorandum of Understanding, Amendment 1 with the RI Office of Energy Resources. (End of memo)

Councilor W. Worthy stated that Council has received a request from Glocester Economic

Development Commission which he read as follows:

Policy

Purpose:

The Glocester Economic Development Commission (EDC) seeks approval from the Town Council to establish and manage a Facebook page that will promote local businesses, attract new businesses, and engage with the community on economic development initiatives. The Facebook page will be operated in accordance with all town policies regarding social media usage to ensure transparency, professionalism, and accountability.

Objective:

The EDC's Facebook page will serve as a key communication platform to:

- .. Promote Glocester's local businesses and events.
- .. Share important updates on economic initiatives and development projects.
- .. Engage with the community on matters related to economic growth.
- .. Provide a space for community feedback and ideas to foster economic development.

Facebook Policy Compliance:

To ensure the Facebook page is compliant with both the Glocester Town Council's social media policy and Facebook's own guidelines, the EDC proposes the following measures:

1. Content Management:

The page will be managed by designated members of the EDC, with one primary administrator and two backup administrators approved by the Town Council.

All content will be pre-approved by the EDC Chair or an authorized member to ensure alignment with town objectives.

Posts will focus on promoting economic development and avoid political endorsements, personal attacks, or inappropriate content.

2. Public Interaction and Moderation:

The Facebook page will be monitored daily to respond to public inquiries and messages. Comments will be only allowed upon approval by an approved administrator.

All interaction with the public via direct messaging will maintain a professional and courteous tone in line with the town's commitment to respectful communication.

3. Compliance with Town and Facebook Policies:

The EDC will strictly adhere to the Glocester Town Council's Social Media Policy, including record-keeping requirements, public records law, and any archiving needs.

The Facebook page will also follow all of Facebook's Community Standards,

ensuring that no content that violates Facebook's terms of service is posted.

4. Security and Privacy:

The EDC will take necessary precautions to secure the Facebook page, including enabling twofactor authentication and maintaining strong passwords. Any shared information about businesses or events will be in compliance with privacy regulations, and no personal data will be disclosed without proper consent.

5. Regular Reporting:

The EDC will submit quarterly reports to the Town Council outlining Facebook page activities, including engagement metrics, community feedback, and any incidents of inappropriate behavior or policy violations.

Conclusion and Requested Action:

The Glocester EDC is committed to fostering economic growth in the community through responsible and transparent use of social media. We believe that managing a dedicated Facebook page will enhance communication, promote local businesses, and engage the public in meaningful discussions about the town's economic future. We respectfully request the Town Council's approval for the EDC to create and manage this Facebook page with designated administrators, with compliance measures in place and following the policies and procedures as outlined in this proposal.

Fecteau, Town Clerk, stated that the town's IT director has some questions. Councilor W. Steere stated that this matter has been before the Council in the past and there were issues regarding managing and monitoring. Councilor W. Steere stated that a big concern for him is the interactive aspect of messaging .Councilor W. Steere stated that the proposal was put together well but he is not in favor at this time.

Councilor S. Calise stated that there are issues in allowing or disallowing as to material. Councilor W. Worthy stated that other towns do have facebook pages but asked about who manages.

J. Fecteau stated that a concern is that the town's current Social Media policy needs to be updated and the IT Director is working on it. Councilor J. Burlingame stated that he would like the EDC to research how other towns with Facebook pages manage them.

Councilor W. Steere stated his opinion that a facebook page is a bad idea as it could put the town in a bad position. Councilor W. Steere stated that Council needs to be cautious .

Councilor W. Worthy stated his recommendation that EDC could do some research and get back to the Council regarding how other towns monitor and manage a facebook page. Councilor C. Greathouse stated her opinion that a facebook page would be a great asset to the town .Councilor W. Steere stated that his concern is the messaging that occurs on a facebook page. Councilor C. Greathouse stated that the facebook page could be announcements and no messaging. Councilor W. Worthy stated that there are challenges to consider but that if it was announcements then that would be repeating information already on the town's website. Councilor W. Steere also stated that the town has a website. Councilor C. Greathouse stated her opinion that a facebook page stated her opinion that she is not sure people use the town's website but that everyone uses facebook.

Councilor W. Steere also stated that a concern is that volunteers would be managing and monitoring the proposed facebook page and not employees. Councilor W. Worthy stated that EDC could do research and report back to Council. B. MacArthur, EDC Chair stated EDC would do the research

and get back to Council.

Councilor J. Burlingame stated that the Glocester schools are asking for a 28% increase in their proposed budget. Councilor J. Burlingame stated his opinion that the percent needs to be reduced. Councilor W. Steere stated that the Council can only reduce the bottom line and not address individual line items.
