Blanca White, Glocester started to ask questions in regard to a special education class that was being moved from one elementary school to another. Attorney Piccirilli stated that it was not an agenda item. Mr. Rizzo stated that it is not a school committee decision, it is a superintendent decision. Dr. Palazzo responded that although this was not on the agenda, if anyone wanted to speak with her in regard to this, to please call her. She stated that to date she had spoken to all parents who called her. This issue was not a budget issue, it was a space issue.

Erin McPhee, Art Teacher at West Glocester and Fogarty, and union president stated that the Girls on the Run program was a good example of what the teachers would not be helping with if the cuts remained. She will advise her union members; there will not be a play, there will not be an art show. The kids will suffer.

Re: Requirements for Scheduling a Special Financial Town Referendum for Supplemental Tax

Dear Members of the School Committee and Superintendent Palazzo:

I am writing to outline the expectations and timeline requirements for a potential Special Financial Town Referendum related to a supplemental tax to support the school department.

As you know, in an effort to rehire laid off teaching assistants and maintain essential services, the Town Council submitted legislation (H6409 and S1155) to the General Assembly. This legislation will authorize, subject to voter approval, a supplemental tax for fiscal year 2026 that exceeds the statutory 4% cap by no more than an additional 3%. The General Assembly has approved the legislation, and it has been transmitted to the Governor for his action.

In anticipation of this legislation becoming law, the Town Council is preparing for the earliest possible date to hold a Special Financial Town Referendum—September 2nd, 2025. To formally adopt the ballot question and schedule this referendum for September, the Town Council must receive the following no later than July 7, 2025:

 A School Committee Resolution that confirms the exact amount requested (subject to the maximum limit of the legislation) and the specific purpose for which the funds will be used; i.e. rehire TA's recently laid off, and 2. A signed letter from the Superintendent of Schools confirming both the exact amount requested (subject to the maximum limit of the legislation) and the intended use of the funds, i.e. rehire TA's recently laid off.

These materials are necessary to ensure that the Town Council can accurately frame the ballot question, provide proper public notice, and assure voters that the request is fully supported by both the School Committee and the Superintendent.

If the School Committee and Superintendent are unable to meet this submission deadline, the next available opportunity to hold a referendum will be in October 7, 2025.

Dear David:

Today, I was forwarded a letter sent by Town of Glocester Council President William Worthy dated June 27, 2025, to the Glocester School Committee members and Superintendent Dr. Renee Palazzo. In the letter, President Worthy references to certain "expectations and timeline requirements", which neither he nor the Council has no legal right to demand.

First, he demands a response by July 7, 2025. The Committee is meeting on July 8, and cannot even discuss this letter until that time. Moreover, what is being demanded has never been addressed to the Committee previously; instead, the Council waited until after the passing of the budget with significant cuts to the Committee's initial budget request, before seeking legislation to override the 4% tax levy cap.

As for what is being demanded, the Council cannot expect the Committee to pass any resolution committing to how it would expend any additional appropriation it may be provided by the Council. Nor can the Council demand of the Superintendent that she commit in writing to what additional budget amount she requests, nor commit to the re-hiring of any specific personnel. As I read the legislation, the Council is given broad discretion as to how to allocate the additional supplemental tax levy; it could give it all to the Committee or keep some or all of it to fund Town expenditures.

What the Council has is the original budget which the Committee presented to the Council back in April, and the budget it passed in May to conform to the cuts made by the Council and the Financial Town Meeting. If any additional funds are appropriated to the Committee for the 2026 fiscal year, the Committee will have to meet to determine how it anticipates making expenditures.

As you know, budgets are projections of expenditures and in no way limit the Committee's obligation to transfer between line items to address unexpected expenditures and ensure there is no budget deficit.
