Erica Dauphines, 107 Gold Mine Road, spoke of her opinion regarding the trees that need trimming along Gold Mine Road and Durfee Hill Road. Councilor W. Steere stated that if the trees are on the roadway then it is a town responsibility but if the trees are not on the roadway then it is the property owner's responsibility. E. Dauphines stated her opinion that most seem to be along the roadway of the state property, Durfee Hill Management Area, on Gold Mine Road. Councilor W. V. Resolution - #2025-10

In Support of Restoration of State General Revenue Sharing to Cities and Towns

Councilor W. Worthy stated that Council has received requests for support from multiple cities and towns to join in the effort to request the state reinstate Revenue Sharing. Councilor W. Worthy stated that the Council asked for a resolution in support which he read as follows:

Resolution #2025-10

In Support of Restoration of General Revenue Sharing to Cities and Towns

Whereas: Cities and Town across Rhode Island have been struggling with the recent

inflationary environment; and

Whereas: In 2009 the General Assembly discontinued revenue sharing due to the

economic collapse; and

Whereas: The removal of General Revenue sharing forced the Cities and Towns to

increase property taxes to make up for this loss in revenue; and

Whereas: The State of Rhode Island has seen a very good rebound from the economic

crisis brought on by the COVID Pandemic; and

Whereas: The past 3 fiscal years the State of Rhode Island has benefitted from the

economic rebound with \$878 million FY 2022, \$410 million FY 2023 and a

\$292 million surplus for FY 2024; and

Whereas: \$70 million of one-time expenses for much needed repairs of our beautiful State

House was built into the FY 2024 budget and can simply be relocated to General

Revenue Sharing.

NOW, THEREFORE BE IT RESOLVED: That the Glocester Town Council hereby requests that the Rhode Island General Assembly and Governor reinstate General Revenue Sharing for all 39 Cities and Towns to help reduce the impact of inflation on the citizens of Rhode Island; and

BE IT FURTHER RESOLVED that the Town Council respectfully requests the respective City and Town Councils of Rhode Island and our local legislators to join in our request to have the General Assembly restore general revenue sharing in the upcoming FY 2027 budget.

Igliozzi stated that at the end of the process, Council will deliberate and make a decision but there is no set time limit.

Amendment

Through the Pandemic Recovery Office, the State has made federal funds available through the Municipal Community Learning Center Program. This program authorizes recipients to use funds for critical capital projects that directly enable work, education, and health monitoring in response to the COVID-19 public health emergency.

The Town is currently in a MOA with the Harmony and Manton libraries for just over \$1,000,000 in capital improvement funds for those buildings. In addition to the capital project funds, the Pandemic Recovery Office is also providing Community Learning Center Programming Support Grants. These funds will be used to implement the health monitoring, work and education programming that will take place in the libraries.

The Town Council signed an agreement for the support programming in November 2024 guaranteeing each library at least \$90,881.82 in no match grant funds. This amendment slightly changes the timing in which the library can receive the funds sand increases the minimum funding for each library to \$95,209.52.

I am requesting authorization for the Town Council President to sign the attached grant amendment agreements, one for each library, which will allow the town to receive these funds and pass them along to the libraries.

Currently, the police department is in year three of a five-year Department of Public Safety Grant Administration program for the procurement, maintenance, and evidence software for body worn video and audio camera program. As part of the public safety grant administration agreement funds are directed for all overtime personnel costs for maintenance, redaction, and copies of videos specifically related to prosecution evidence, and open records requests. This detailed evidence documentation and open records requests requires hours to successfully complete.

This year, there are \$14,000.00 in Department of Public Safety Grant Administration funds available for incurred overtime expenses for this process.
