VII. New Business

Owen explained his proposal, by the Owen family, to sponsor the placing of a memorial rock on town hall premises honoring his family's ancestor, Lieutenant Governor Daniel Owen. Councilor W. Worthy stated that Owen presented a power point presentation and gave a handout of the power point to each councilor describing the project.

Councilor W. Worthy stated that the placing of the monument is set to coincide with the 250th celebration. Councilor W. Worthy stated that the Clerk has spoken with the Public Works Director who will oversee the choice of a stone and set the stone in place.

Unfortunately, I am unable to attend this council meeting but would like to ask for back up coverage for the Town's inspectors. This coverage would be for emergency situations if the appointed full-time inspector was out sick or vacation and there is an inspection that cannot wait till they returned. They will only be utilized on an as needed basis. This week we have been faced with an inspector out due to illness and had to call around and get someone from Foster to cover a service inspection that needed to be done. It would be nice to have a plan in place with coverage when and if needed instead of scrambling to find someone at the last minute.

Currently we have one inspector for each classification except for Roland Belanger who is certified in both Plumbing as well as Mechanical.

I would like to add Michael Paolucci, a certified Electrical Inspector for the town of Foster and Robert Lubera, who is certified in Mechanical and Plumbing. This coverage would not change our existing budget and these individuals would be compensated just as our appointed inspectors are.

This will also include Larry Desormier.
